Police Events. Police responded to 180 events in August/September. Most frequent were vacation home/business checks/ requested extra patrols (75), medical emergencies (16), attempt to locate careless drivers (10), traffic violation citations/warnings (9), fire/burglar alarm responses (8), and animal complaints (7). The Town Board had hearings on two complaints and follow-up on two continued problems.

Emergency Generators. The Township has an emergency backup generator at the Town Hall and at Fire Hall 1 on Ryan Road. The Town Hall and Fire Hall 1 are designated in our **Township Emergency Plan** as our Emergency Operation Center (EOC) and Backup Center (*see the web site for the Plan*).

Our current Emergency Management Co-Directors are **Ann Cox** and **Sherry Rovig** (EMD's). There is an **Emergency Planning Group** that meets to review emergency plans. The current focus is on reducing wildfire threats due to the spruce budworm damage (*the FIREWISE cleanup and chipping program*) and getting reflective 911 signs distributed and properly installed (*sign pick-up is handled by Co-EMD Ann Cox during office hours*). Grants have been received for much of this work, thanks to Co-EMD Sherry Rovig and others.

There is No Poop Fairy

This humorous video is one of the many collaborations between Duluth Township and the Regional Stormwater Protection Team to help meet our state education requirements for stormwater. While concern with pet waste in a rural area such as our Township, may seem unnecessary, fecal matter contains bacteria and nutrients and when rain washes it into ditches and streams, it is a threat to clean water and recreational opportunities.

Be mindful of the areas where your pets (including large animals such as horses and livestock) go and fence them away from areas that are vulnerable to drainage into ditches and streams. We all benefit if we, our animals, and the environment are not exposed to poo-contaminated waters. If you live in an area with small lots, do pick up pet waste and dispose of it. If you are walking your pets in public areas, please take along bags to clean up.

CCC Camp on Stoney Point — Part 2

The last *Duluth Township Newsletter* (September 2019) reported the **Lakeshore Wayside Park, Civilian Conservation Corps (CCC) Camp No. SP-18**, opened September 27, 1935. The camp was located close to the shore of Lake Superior in the area just north of the stone wall which fronts the lake at the point where Stoney Point Drive (west entrance) turns east to skirt the lakeshore. The camp remained open through much of 1937.



Some of the camp buildings are shown in the aerial photo above. Most likely the Lakeshore camp began as a temporary tent camp and the enrollees built the more permanent structures with logs as well as lumber milled from trees in the area. In many CCC locations unemployed local craftsmen were recruited and paid to assist in the building, particularly in those areas where winter conditions demanded warmer shelter. This may have been the case at Lakeshore. Buildings included barracks, mess hall, kitchen, officers' quarters, dispensary, rec. hall, store house, latrine and bath house. The structures were built to last about five years. Camps were self-contained and staffed with doctors — or medical support. Dentists, if not on site, visited regularly.

In the June 18, 1936 issue of the "Lakeshore Camp News (Co. 1751 CCC)" the commanding officer congratulates company members: "Every individual in this camp has shown me and the other officers an exhibition of how immature boys become real men under the cooperating guidance of appointed leaders. Resourceful futures are waiting for that type of young man who goes out with aching back and tired limbs to dig holes, plant trees, paint and beautify the barracks, lay company streets and sidewalks, and always remain in a joyful mood." Tightly scheduled days devoted to hard work under careful supervision led, it was assumed, to character building.

Enrollees were required to be "needy unemployed," between the ages of 18 and 25, U.S. citizens, physically fit, and capable of manual labor. That age limit led to some grumbling about discrimination; certainly there were large numbers of older, unemployed men having difficulties supporting their families. So, some months into the program the CCC began recruiting locally experienced men who acted as foremen and brought valuable trade skills as carpenters and stonemasons to specialized work projects. The young men—boys, they are called in the newsletter— signed six month enrollment contracts initially, but many of them reenlisted and eighteen months after the program began (1933), contracts were extended to one year. Enrollees received a dollar a day and could keep up to eight dollars, the rest being sent to dependents and parents, many of whom were very grateful for that cash. Food, shelter and clothing (army uniforms, WWI surplus) were provided. As the numbers of recruits increased exponentially, and there were ongoing complaints about the old uniforms, new fatigues were provided.

While the principle motive for enrolling might have been helping their families, many of the boys also wanted to improve their literacy or continue high school educations. English classes were regularly offered. Other educational offerings focused on vocational skill development: photography, auto mechanics, lettering and sign painting, business English, typesetting, agriculture. Reading was encouraged when time allowed: *Time*, *Colliers*, *Literary Digest*, *Liberty*, and *American* were some of the periodicals available in the Rec. Hall. Enrollees were often reminded to consider the question: "Where do we go from here?" The CCC program was never meant to offer long term employment and benefits. Most boys spent between a year and 18 months in camp. In creating CCC, President Roosevelt stipulated the program not interfere with normal employment. During CCC's life, unions regularly objected to what they considered labor exploitation. They were probably more concerned about the low wages.

Many of Lakeshore's boys were from this area. There are lists of names of Duluth residents as well as individuals from the Iron Range. Perhaps because so much time has passed, there are not many locals who remember the camp even though it was in Duluth Township. Helen Hendrickson knew there was a camp "down there." Howard Abrahamson remembers numbers of young men hitching into Two Harbors on weekends. One of Merle Norgren's childhood companions, sliding on cardboard down a hill behind the Shorecrest Restaurant, ran into a pitchfork. His father took the youth, his friends riding along, up the shore to the CCC camp for medical attention. Merle says the camp roads were straight and picked up. Carol Pierson remembers when "the government people" moved out they left a lot of stuff. Her mother recovered a cupboard with drawers and shelves which the family used as a room divider in their small home on Stoney Point. Carol's brother, John Rasmussen, says the camp was vacated suddenly; a clean-up crew gave tools to locals, and dumped a quantity of picks and shovels in the lake. People fished them out of the lake as needed, and John says there was no shortage of such tools in the area for years.





Summary of Planning Commission Meetings

(Official minutes by Planning Secretary Beth Mullan are available on our Township web site www.duluthtownship.org)

August 22nd regular meeting. Commissioners Wayne Dahlberg, Dave Edblom, Jerry Hauge, Liz Strohmayr (*chair*), Pam West, Angela Wilson, and Larry Zanko attended along with the Planning Director Sue Lawson, and Secretary Beth Mullan and Board Liaison Mike Kahl.

An appeal of a decision by the Planning Director about a conditional use for a short term rental on an under sized lot on the shore. The owners have a separate property near but not contiguous with the proposed short term rental house. The Commission set the appeal notification area of 1/4 mile of the property. The hearing was slated for the September meeting but was postponed to the October meeting.

A question was raised about a possible repair shop for autos, pickups, and some larger vehicles and trailers at Lismore and McQuade roads. It was decided the use would come under Highway Commercial Use.

The Comprehensive Land Use Community Steering Group finalized and approved the draft version for the vision for the 2030 CLUP.

September 26th regular meeting. Commissioners Wayne Dahlberg, Dave Edblom, Jerry Hauge, Liz Strohmayr (*chair*), Pam West, Angela Wilson, and Larry Zanko attended along with the Planning Director Sue Lawson, Secretary Beth Mullan and Board Liaison Mike Kahl.

Owners of a short term rental on West Knife River are applying for a conditional use permit. The notification area was set at the usual 1/4 mile.

The Planning Director, Sue Lawson reported on short term rental policy and how it applies in various situations, progress on the Steering Group's work toward a Comprehensive Land Use Plan update.

Regular **Planning Commission meetings** are held on the fourth Thursday at **6:30pm** in the Town Hall.

Special hearings are also posted at the Town Hall. Residents are encouraged to attend these public meetings.



Summary of Town Board Meetings

September 12th regular meeting. Supervisors Rolf Carlson (*chair*), Michael Kahl, John Schifsky and Corlis West attended along with the Town Clerk Ann Cox and Treasurer Mel Peulen.

Reports: Treasurer: Deposits of \$40,536.93, expenses of \$45,831.04 for an ending balance of \$513,463.52.

Public Speaker Laura Stone of the Knife River Community Forest Group was unavailable.

Reports: Police: Dog complaints: second violation for owners of (Turbo), and owners of (Rev). Rev has been taken home twice since early September. Animal Ordinance 101096 has a \$100 fine for a second violation. A motion was unanimously passed to assess a fine for Turbo's owners and, (*due to different circumstances*) Rev's owners will be sent a notice to appear at the next Town Board meeting. **Fire:** PERA, the Fire Fighter Pension Fund, will be asked for a cost analysis on the relationship of the healthy level of our pension fund and the current per-year payout schedule for Fire Fighters when they retire.

The Fire Department is sometimes asked to fill the steam train when it stops at Homestead. The Department will negotiate a more formal cost agreement with the railroad. **Roads:** Fall grading is being done. Initially roads were too dry and then too wet. There was a complaint of individuals spinning tires and ripping up West Clover Valley Road. **Town Hall:** insurance documents will be reviewed. Our well water will have its required chlorine treatment. **Communication:** A replacement for the current volunteer editor is being sought and a motion was approved to earmark an annual stipend.

Regular **Town Board meetings** are held on the second Thursday at **6:30pm** in the Town Hall.

(special meetings are posted at the Town Hall). Residents are encouraged to attend these public meetings.
